#### Adjuvant:

Infiltrate excels at assisting in proper soil profile placement of pre-emergent herbicides, insecticides, and nematicides. A rate of 1.5 to 3.0 ounces per 1,000 sq. ft. is recommended.

## Standalone Penetrant:

When using Infiltrate as a standalone penetrant an initial application rate of 2 gallons per acre is recommended, followed by 1 gallon per acre for maintenance.

Many pesticides will have stated adjuvant use-rates on their labels. In all cases, the pesticide manufacturer's label should be consulted and followed regarding specific adjuvant usage recommendations.
